

## **SPECIAL CALL MEETING AUGUST 26, 2012**

Be it remembered that the Mayor and Board of Aldermen of the City of Ocean Springs met in a Special Call Meeting at the Ocean Springs Fire Station, 3812 Bienville Boulevard in the City of Ocean Springs at 1:30 p.m. on August 26, 2012. Mayor Moran presiding, Aldermen Gill, McDonnell, Cody, Denyer, Dalgo and Hagan were present. Also present were City Clerk Shelly Ferguson and City Attorney John Edwards. Alderman Cox was absent.

The Mayor called the meeting to order.

The Special Call Meeting is for the purpose of any and all matters pertaining to the Proclamation of Existence of a Local Emergency, Tropical Storm Isaac.

Nate Wilson, EOC Director, gave an update on Tropical Storm Isaac. He stated the storm was expected to make landfall in the Biloxi/Gulfport area on or around 7:00 p.m. on Tuesday, August 28<sup>th</sup> with winds approximately 100 mph. Sand and sandbags will be available to the public beginning today at the Public Works Department on Pine Drive. The Public Works Department will pick up trash throughout the City beginning Monday.

Dr. Coleman-Potter gave an update on the schools. She stated the school district will have a meeting at 10:00 a.m. on Monday, August 27 to determine the need to close the schools.

Motion was made by Alderman Dalgo, seconded by Alderman Hagan and unanimously carried to open the public meeting.

Motion was made by Alderman Cody, seconded by Alderman Gill and unanimously carried to proclaim an existence of a local emergency by the Mayor and Board of Aldermen of the City of Ocean Springs, Mississippi caused by the threat of Hurricane/Tropical Storm Isaac commencing on or about 1:30 p.m. on the 26<sup>th</sup> day of August, 2012.

Motion was made by Alderman Hagan, seconded by Alderman Gill and unanimously carried to close the public meeting.

The Building Official stated all A-frame, banners and signs need to be removed throughout the City during the storm.

The need for shelters was discussed.

The Public Works Director advised all debris contractors should be directed to their office and will be determined through a bid process.

Motion was made by Alderman Hagan, seconded by Alderman Gill and unanimously carried to recess until August 27, 2012 at 2:00 p.m. at the EOC.

The meeting ended at 2:57 p.m.


