

SPECIAL CALL MEETING AUGUST 28, 2012

Be it remembered that the Mayor and Board of Aldermen of the City of Ocean Springs met in a Special Call Meeting at the EOC located at the Ocean Springs Fire Station, 3812 Bienville Boulevard in the City of Ocean Springs at 3:00 p.m. on August 28, 2012. Mayor Moran presiding, Aldermen Cox, Gill, McDonnell, Cody, Denyer, Dalgo and Hagan were present. Also present were City Clerk Shelly Ferguson and City Attorney John Edwards.

The Mayor called the meeting to order.

The Special Call Meeting is for the purpose of any and all matters pertaining to the Tropical Storm/Hurricane Isaac.

Nate Wilson, EOC Director, gave an update and projections on Tropical Storm/Hurricane Isaac. Isaac has now been upgraded to a Hurricane. The weather will continue to deteriorate throughout the day with 40 mph winds and gusts up to 50 mph. The forecasted track has Hurricane Isaac moving west and making landfall Wednesday morning.

The Public Works Director gave an update on the streets with possible flooding issues.

The National Guard has been posted on East and Front beaches to keep people off the beaches. They are also patrolling the low lying areas and advising residents of the mandatory evacuation.

Supervisor McKay stated there is a County-wide curfew from 10:00 p.m. – 7:00 am. for one night and will re-evaluate the curfew on Wednesday.

Motion was made by Alderman McDonnell, seconded by Alderman Gill and unanimously carried to follow the same curfew issued by the County for Tuesday night and authorize the Mayor and Police Chief to impose curfews for any additional nights as needed.

Motion was made by Alderman McDonnell, seconded by Alderman Gill and unanimously carried to appoint Andre' Kaufman as Agent of Record for Hurricane Isaac.

All department heads will meet with storm coordination after the storm has passed.

Motion was made by Alderman Cody, seconded by Alderman Gill and unanimously carried to adjourn the Special Call meeting.

The meeting ended at 3:40 p.m.


