

## **SPECIAL CALL MEETING MARCH 13, 2013**

Be it remembered that the Mayor and Board of Aldermen of the City of Ocean Springs met in a Special Call Meeting at City Hall in the City of Ocean Springs at 5:00 p.m. on March 13, 2013. Mayor Moran presiding, Aldermen Cox, Gill, McDonnell, Cody, Denyer, Dalgo and Hagan were present. Also present was Deputy City Clerk Karen Kennedy.

The Mayor called the meeting to order.

The Special Call Meeting is for the purpose of any and all matters pertaining to strategic planning facilitated by Ms. Joy Saucier from the Economic Development Division of Mississippi Power Company.

Ms. Joy Saucier with Mississippi Power Company served as the facilitator to review the strategic planning for capital improvements and prioritize future projects.

The Mayor presented a power point of the accomplishments the City has achieved over the past years, such as the Ocean Springs Sports Complex; Public Safety Complex; renovation of the Dewey Avenue Substation; new tennis pavilion; improvements to Front Beach; Shearwater Park; harbor improvements; \$1M in drainage improvements; sidewalk improvements; downtown beautification; signage improvements and extended Central Business District for the tax abatement program.

There was discussion on the harbor improvements, boat trailer parking and additional green space at the harbor.

The public had an opportunity to recommend what issues and projects they would like to see the City achieve for the next 18 months and the next 5 years.

Among some of the projects listed were drainage improvements, infrastructure, beautification, improve parking in the downtown area, recruit more microbreweries, sidewalks; complete the 2% projects; railroad crossings; dog park; improvement boat trailer parking and city-wide economic development.

Motion was made by Alderman Cody, seconded by Alderman Hagan and unanimously carried to adjourn the special call meeting.




