

## **SPECIAL CALL MEETING MAY 10, 2013**

Be it remembered that the Mayor and Board of Aldermen of the City of Ocean Springs met in a Special Call Meeting at City Hall in the City of Ocean Springs at 5:00 p.m. on May 10, 2013. Mayor Moran presiding, Aldermen Gill, Cody, Denyer and Dalgo were present. Also present was Deputy City Clerk Karen Kennedy. Aldermen Cox, McDonnell and Hagan were absent.

The Mayor called the meeting to order.

The Special Call Meeting is for the purpose of any and all matters pertaining to postponing Mayfest, 2013 from Saturday, May 11, 2013 to Sunday, May 12, 2013.

The Mayor asked the Board to consider moving the Mayfest event from Saturday, May 11th to Sunday, May 12<sup>th</sup> due to inclement weather.

Mr. Arturo Barajas, the event organizer, stated the schedule of events would remain the same. Alderman Cody asked to that the bands not begin playing until 11:30 a.m. so as not to interfere with church services at the First Baptist Church.

Motion was made by Alderman Gill, seconded by Alderman Dalgo and unanimously carried to postpone Mayfest, 2013 from Saturday, May 11, 2013 to Sunday, May 12, 2013, with the festival beginning at 10:00 a.m. and music to begin at 11:30 a.m.; approve Resolution of the City of Ocean Springs to temporarily allow consumption of beverages and sale of beer on public property for Mayfest, 2013 and streets to close on Sunday, May 12<sup>th</sup> at 6:00 a.m. on Government Street at Washington Avenue to Bellande; at 9:00 a.m. to Russell and streets to open at 10:00 p.m. on May 12th.

Motion was made by Alderman Gill, seconded by Alderman Dalgo and unanimously carried to approve the Temporary Dedication of Land for Public Purpose pending approval of the First Baptist Church Board of Trustees.

Motion was made by Alderman Dalgo, seconded by Alderman Gill and unanimously carried to adjourn the Special Call Meeting.


