The candidates, Jane H. Moore and Nickie A. Overby, were interviewed by the Board by phone conference.

The Mayor arrived and assumed control of the meeting.

The Board casts a ballot vote with Aldermen Gill, McDonnell, Cody, Dalgo and Denyer voting for Wally W. Carter, Alderman Cox voting for June H. Moore and Alderman Impey voting for Bradley P. Patano.

Motion was made by Alderman Gill, seconded by Alderman Dalgo and unanimously carried to appoint Wally W. Carter to the Ocean Springs School Board, term expiring February 28, 2020.




