

SPECIAL CALL MEETING OCTOBER 27, 2016

Be it remembered that the Mayor and Board of Aldermen of the City of Ocean Springs met in a Special Call Meeting at City Hall in the City of Ocean Springs at 6:00 p.m. on October 27, 2016. *Mayor Pro Tem* Impey presiding, Aldermen Cox, Gill, McDonnell, and Cody were present. Also present was City Clerk Shelly Ferguson and City Attorney Kevin Melchi. The Mayor and Aldermen Dalgo and Denyer were absent.

The *Mayor Pro Tem* called the meeting to order.

The Special Call Meeting is for the purpose of any and all matters pertaining to the Food and Beverage 2% Tax Bond refinancing and any matters that are associated with the Food & Beverage Fund and to authorize the Special Event Application for Trick or Treat Down the Street hosted by HOSA.

Motion was made by Alderman McDonnell, seconded by Alderman Cody and unanimously carried to approve the Special Event Permit application for Trick or Treat Down the Street on October 31, 2016. (Exhibit b)

Demery Grubbs presented (2) two options, Surety Funded and Cash Funded options, for refunding of the 2009 Special Obligation Bonds the city obtained for the purpose of Public Safety and Recreation through the 2% Food and Beverage Tax. Mr. Grubbs recommends to go with the Cash Funded option. This option is to leave the reserve funds where they are, do not disrupt our system, and authorize to refund the bonds as straight up refunding carried to the MS Development Bank refunded as a standard refunding and we still save a projected amount of \$500,000.00.

Motion was made by Alderman McDonnell, seconded by Alderman Gill and unanimously carried to follow Demery Grubbs recommendation to go with the option of the upfront savings with the Cash Funded option.

Motion was made by Alderman Gill, seconded by Alderman Cody and unanimously carried to adjourn the Special Call Meeting.
