Motion was made by Alderman Gill, seconded by Alderman Cox to adopt the Resolution Fixing the Tax Levy of the Municipal Ad Valorem Taxes on the City of Ocean Springs, Mississippi, and the Ocean Springs School District, Jackson County, for the Fiscal Year 2017-2018 with Aldermen Cox, Gill, Authement, Bellman, Papania, and Blackman voting aye and Alderman Impey voting nay. Motion was made by Alderman Authement, seconded by Alderman Bellman and unanimously carried to approve a Child Daycare Center located at 1171 Ocean Springs Rd. (PID #60122070.40) in the C-4-A Commercial Limited Zoning District (Hospital related businesses and services) as recommended by the Planning Commission. (Exhibit c)


