

## **SPECIAL CALL MEETING AUGUST 25, 2020**

Aldermen Papania and Impey, City Attorney Nicole Sullivan, Public Works Director Allan Lадnier and the Planning & Grants Administrator Carolyn Martin joined by Zoom teleconference. The Fire Chief gave an update on Hurricane Laura. He said he would be updating the City following the National Hurricane Center Advisory Schedule. He said they issue an update every six hours. He said with this storm Ocean Springs should expect 1 to 5 feet of storm surge. He recommended no action at this time.


